The Rules Are Simple:

- Contest entries are due no later than **July 15, 2018**.
- Photos should have been taken since January 1, 2017. (We want to cover all the seasons, so look through your photo files from as far back as a year and a half!)
- Photos must have been taken in Clarke County, Virginia.
- Photos will be judged on content, contrast, composition, and creativity.
- Photos may be submitted electronically (preferred) as high-resolution images or in print form.
- Up to five entries per person.
- All community members are eligible to participate.
- Winners will be selected from three photographer categories: **Professional, Amateur, and**

Student. Students should be 17 and under; to participate, all minors must have a parent or guardian complete the form found at www.clarkelandconservation.org.

- First, second, third, and honorable mention photos will be selected from each category. (We reserve the right also to name Special Merit winners.) First-, second-, and third-place winners will receive \$300, \$200 and \$100 gift cards, respectively, to a professional photography shop.
- For electronic images, send a separate file for each entry, with the file name including your name and a number (1, 2, 3, if submitting more than one), to ateetor@clarkecounty.gov. Include your contact info (name, address, phone number, email address).
- Preferred size of photographs is

1 MB or larger at 72 DPI or more. You may submit smaller-sized images, but images with a low resolution are less likely to be considered as finalists.

- Maximum size of print images is 8" x 10".
- Photo captions must accompany all submissions and should include a description of the subject in the image, the location where the image was taken, and the name of the photographer.
- Photos must be the original art of the entrant. Violators will be eliminated from the competition.
- The photographer is responsible for obtaining the permission of any individuals depicted in images.
- Winning entries will be exhibited in the community in 2018 and beyond.

- The photographer retains all rights to photographs submitted. He or she also grants the Easement Authority a nonexclusive right, in perpetuity, to publish the images for the Authority's purposes in any format, including on our website and in our publications or presentations, such as newsletters, emails, brochures, grant proposals, displays, and mailings. The photographer also grants use, in connection with the photo contest, of his or her name, city/county, and state in promotions and other publications. As conditions of this permission, the Easement Authority will credit all photographs with the photographer's name.

The Judge

The contest will be judged by Ken Garrett, a distinguished photographer whose work has appeared in *National Geographic*, *Smithsonian*, *Air and Space*, *Archaeology*, *Fortune*, *Forbes*, *Time*, *Life*, *Audubon*, *GEO*, *National Wildlife*, and *Natural History*. Specializing in archaeology, paleontology, and ancient cultures worldwide, Garrett has photographed for such books as *El Templo Mayor: The Great Temple of the Aztecs in Mexico*; *Floaters and Stickups*; *Egypt of Pharaohs*; *Tutankamun and the Golden Age of the Pharaohs*; and *Bulgaria's Gold Rush*. His work has been exhibited at the Smithsonian Institution, the University of Pennsylvania Museum of Archaeology & Anthropology, and in Egypt, Cuba, and Japan.

A resident of Broad Run, Virginia, Garrett received a B.A. in anthropology from the University of Virginia in 1976.
