## Clarke County Easement News

Tupper Dorsey & Family Honored with 10th Wingate Mackay-Smith Award

or the past 10 years, the Clarke County Conservation Easement Authority members have gathered with area leaders annually to spotlight an individual or organization who has been vital to the county's success as one of Virginia's best at protecting land through easements.

In February, a special gathering at Millwood Country Club honored the 2023 recipient of the Wingate Mackay-Smith Land Conservation Award – Tupper Dorsey and Family – and took time to celebrate those honored throughout the decade of awards. (See article at right.)

With the Dorsey family, the selection was easy. "This is a family that lives and breathes the concept of preserving Clarke County resources," said George Ohrstrom II, vice chair of the Authority. "With 732 acres in conservation easement, the Dorseys have incorporated natural resource conservation into their businesses and their lifestyle."

"Thank you, Tupper and Wendy, for your approach to land conservation, your business philosophy, and your love of the land. You've helped move Clarke County's conservation easement program forward, preserving and protecting our natural resources

forever...But I have to say one of the most impressive traits of this honoree is the family's mindset: That the combined strength of the county's easement community genuinely makes the difference." As Tupper and Wendy accepted the Wingate Mackay-Smith Land Conservation Award, they thanked the Easement Authority and county leaders for their land-conservation focus. And Tupper issued

a friendly warning: "It's going to take even more work because development pressure is coming from everywhere." The goal of the Wingate Mackay-Smith Land Conservation Award is to honor individuals, groups, or organizations for outstanding contributions to protect our open spaces in Clarke

County, to build awareness of the need for land conservation in Clarke County, and to showcase the positive role that conservation easements play in preserving the natural, scenic, cultural, and historic resources of the county.

## **Land Conservation Award Winners** elebrating the tenth year of the Wingate Mackay-Smith Land

Conservation Award, the Easement Authority invited previous winners to join the special luncheon.

'All of these individuals and groups have played incredibly important roles in land conservation in the county - and for many different reasons," explained George Ohrstrom II, vice chair of the Authority. "They have been and many still are conservation easement leaders in our community, helping to forge the path for others and dispel the myths that often surround easements.

Lorien Lemmon, the County's Conservation Planner and liaison to the Easement Authority, read the list of honorees, several of whom were at the event.

**2014:** Wingate "Winkie" Mackay-Smith. Or, as often noted, the "Queen" of conservation easements in Clarke County. Winkie helped found the Easement Authority, negotiated the first easement at Greenway Court, and still works diligently to identify and educate landowners. These reasons and more are why this award was named

**2015:** Holy Cross Abbey. The Holy Cross Abbey community

has now placed nearly 1,200 acres of riverside land in easement. Beginning in 2009, Holy Cross was courageous in taking this step because the idea of easements wasn't "mainstream" then, but the decision-makers believed in preserving the land and are exemplary **2016:** Sliding-Scale Zoning Pioneers – Pete Dunning, Bob

Lee, Bob Mitchell, and Margaret Maizel. What can be said about this quartet of forward thinkers? The group's initiative, research, hard work, and courage paved the way for sliding-scale zoning in Clarke County beginning in 1980. **2017: Melvin Kohn.** In 2007, Dr. Kohn, a sociology professor

land as part of their livelihood. Sipe Christmas Tree Farm in White Post was a not-to-miss holiday destination for many residents until it recently closed. The Sipes placed their 177 acres in easement in 2007. 2019: J. Michael Hobert.

As a district supervisor from 1999 to 2015, Hobert was instrumental in establishing the Easement Authority. And as a local attorney, he became an educator about conservation easements in the community and an ambassador for the cause. **2020:** Cool Spring

Battlefield. With 195 acres in easement, Cool Spring Battlefield with the American Battlefield Trust and Shenandoah University were honored for protecting their open space and allowing the historic area to be a welcoming place for residents during the pandemic. 2021: Charles "Chuck"

Johnston. As a former Clarke County planning director, Johnston designed the county's Conservation Easement Purchase Program that the Board of Supervisors created by Ordinance in 2002. He did the research, established the criteria, wrote the code - all the critical details that make the program work today.

2022: Prue Anderson. As a behind-the-scenes volunteer extraordinaire, Anderson for many years monitored easement properties, placed easement signs, made phone calls, and did whatever it took logistically to move the easement mission forward.

2023: Tupper Dorsey & Family. (See article at left.)
